## **Standardized Testing Accommodations**

#### **College Board**

With student and parent permission, testing accommodation requests are submitted to the College Board (PSAT, SAT Reasoning and Subject Tests, Advanced Placement exams) at the end of 9<sup>th</sup> grade or when a student is initially classified or receives a 504 Accommodation. If approved, the student will receive a letter with a unique SSD number. This number must be provided when registering, on-line, to take the SAT Reasoning or Subject Tests. As PSAT and AP registration takes place in school, the SSD number is not required.

Unlike the College Board, the ACT will only permit a student to request testing accommodations at the time he/she is ready to test. For most students this will be in 11<sup>th</sup> grade. Applications are available in the Counseling Office, or on the ACT website, and they must be completed by the student/parent and a school official. To allow for the timely submission of the application, <u>it is essential that the application is</u> <u>submitted to the Counseling Office at least two (2) weeks prior</u>

As required by colleges and universities, **we will** 

forward a copy of your final transcript as soon as it is available in late June.

#### **Student Athletes**

If you will be participating in Division I or II collegiate athletics, you are **required**, by the NCAA, to complete an Amateurism Certification. To do so, log onto your

#### **Student Athletes**

If you are hoping to participate in a Division I or II collegiate athletic program, be sure to register with the NCAA Eligibility Center and request that a copy of your final 11<sup>th</sup> grade transcript be forwarded to the NCAA for an eligibility review. Be sure to print the Transcript Release form at the end of the registration process and submit it to the Counseling Office.
